WHEREAS, David A. Kaplan, Long Branch Sewerage Authority Auditor, has made a written report to the Authority dated June 14, 2017, attached hereto and made a part hereof, regarding the recalculation of the Authority's connection fee Pursuant to N.J.S.A. 40:14A-8; and
WHEREAS, said report recalculates the connection fee at \$4,205.00 per unit and a per gallon per day connection fee of \$21.52 per gallon for all non-residential connectors, and
WHEREAS, this new connection fee will take effect upon ratification by the Authority after a public hearing scheduled for July 19, 2017, and
